If the music or specific songs being requested are not easily available or obtainable, you can request a custom arrangement at an additional cost of \$100 per song.

7. **Deposit: \$100 to be paid with the return of contract via check or venmo.** The event date is not officially reserved until we receive a deposit. This will be deducted from the total.

- 8. Payment:** PURCHASER will provide a check made payable to ***Patricia Rose*** for _____ upon the arrival of the ARTIST to the venue on the date of the event or rehearsal, whichever occurs first. Please deduct the deposit amount from the total cost to determine the amount due on this day. *If alternative payment forms are requested by PURCHASER, please reach out as soon as possible to resolve payment
- 9. Equipment:** PURCHASER shall provide one non-folding chair with backrest and no arms for each member of the ensemble, as well as adequate lighting and space. **If outdoors, PURCHASER will provide a tent or cover which provides adequate protection and shading for ARTIST and their instruments.** ARTIST will provide music stands.
- 10. Weather:** In the event of inclement weather, which includes tornado warnings, blizzard or flood conditions, or if it is truly unsafe to drive, the ARTIST will not attend. If ARTIST is at the venue during the scheduled event/performance times and any of these extreme conditions arise, ARTIST will leave before conditions worsen (if it is safe to do so) or seek safe shelter immediately. If the event is outdoors and it begins to rain/snow/ or extreme weather arises during the ceremony/performance, ARTIST will stop playing immediately and seek indoor shelter or cover to prevent instruments from being harmed or destroyed by the elements.
- 11. Cancellation:** PURCHASER reserves the right to cancel the event performance no later than 14 days prior to the scheduled event date in which case the deposit shall be forfeited.
ARTIST reserves the right to withdraw from event performance no later than 30 days prior to the scheduled event date in which case the deposit will be returned to PURCHASER.
ARTIST is expected to uphold performance obligations unless serious injury or illness prevents them from doing so.
