



## Standard Performance Agreement

7. **Pricing:** \$400 for 1-hr performance, additional playing is billed in 30 minute increments at \$350/hr\*
8. **Deposit: A non-refundable \$100 deposit is to be paid with the return of contract.**  
Event date is not reserved until we receive your deposit. This will be deducted from the total.
9. **Payment: PURCHASER(S) will provide cash, venmo, or check for**  
\_\_\_\_\_ **upon the arrival of the ARTIST to the venue on the date of the event.**

**10. Equipment:** PURCHASER(S) shall provide one non-folding chair with backrest and no arms for each member of the ensemble (3 chairs in total,) as well as adequate lighting and space. **If outdoors, PURCHASER(S) will provide a shade tent or cover.** ARTIST will provide music stands.

**11. Weather:** In the event of inclement weather, which includes tornado warnings, blizzard, flood conditions, or if it is truly unsafe to drive, the ARTIST will not attend. If the event is outdoors, ARTIST may refuse to play in rain, high heat, and extreme cold for the safety of their instruments and health.

**12. Cancellation:** PURCHASER(S) reserves the right to cancel the event performance no later than 14 days prior to the scheduled event date in which case the deposit shall be forfeited.

ARTIST reserves the right to withdraw from event performance no later than 30 days prior to the scheduled event date in which case the deposit will be returned to PURCHASER(S).

ARTIST is expected to uphold performance obligations unless serious injury or illness prevents them from doing so.
